The application may be submitted once the person convicted of the criminal offense has fulfilled the conditions of probation or sentence and discharge by the Court. If the Judge grants the application, the judgment of guilt is set aside and reported to the Motor Vehicle Division and/or the Department of Public Safety in accordance with the statute. Not all criminal offenses are eligible to be set aside. For information on non-eligible charges please review A.R.S. §13-907E.

It is the applicant's responsibility to ensure the Prosecutor's office receives a copy of your filing. After the opposing party has had an opportunity to review your motion and respond, the Judge will review and rule within 2-3 weeks.
