**YOU HAVE RECEIVED A TRAFFIC CITATION. THIS DOCUMENT WILL EXPLAIN YOUR OPTIONS.**

- **READ THIS ENTIRE FORM THOROUGHLY.**
- **READ BOTH SIDES OF THE TRAFFIC CITATION.**
- Failure to comply with requirements of the citation may result in an arrest warrant, entry of default judgment, suspension of your driving privileges, addition of collection costs, and/or other penalties.

Your traffic citation has check boxes to the right of each violation. You must appear in court or complete and submit one of the options below on or before the appearance date shown on the citation. **You may need to choose more than one option if more than one violation is listed on the citation.**

**Option 1 (Guilty/Responsible): Pay online, by mail or by phone.**

You may pay for your traffic violation(s) online, by mail or phone if the violation amount is shown on the Fine/Sanction Schedule on the back of this form or on the online schedule. If the violation is not listed on the schedule, you must appear in court on the date indicated on your citation. **Warning: When you pay by mail, you must still enter your plea by completing the information listed under Option 1 and mailing your signed plea to the court. When you pay online, you may enter your plea online.**

2. Enter the bond amount for each violation as listed on the citation and Fine/Sanction Schedule.

3. **Purchase a money order** for the total of all violations payable to the appropriate court. No personal or company checks accepted.
4. **Read and sign: I understand I am giving up the option of attending defensive driving. I hereby waive my right to a trial/hearing, enter a plea of guilty/responsible, and consent to judgment imposing the prescribed fine/sanction. I further understand Motor Vehicle Division will be notified of the finding of guilty/responsible and points may be assessed to my driving record for any moving violation. If I am not an Arizona resident, other penalties/points may be assessed in my home state. I am enclosing the prescribed fines or have paid online. I do not want a hearing/trial.**

**Option 2 (Not Guilty/Not Responsible): Request a court hearing/trial.**

If you request a hearing or trial, you will not be able to attend defensive driving school. On receipt of your not responsible/not guilty plea, the court will set a hearing date. Be prepared to present your case in Court on that date. If you are found guilty or responsible, the fines are due in full by 4:30 p.m. on the day of the hearing/trial. If the charges are criminal, your case will first be set for a pretrial. The trial date will be scheduled for a later date. You must appear for both proceedings. Complete the following steps.

4. **Read and sign below: I understand I am giving up the option of attending defensive driving. I enter a plea of not responsible/not guilty and request a court hearing/trial for the violations indicated in Step 2. I further understand that if I fail to appear for any reason, the proceeding may take place in my absence, my driving privileges may be suspended, default judgment may be entered on any civil violations, the case sent to collections, and additional fees may be assessed. On criminal charges, a warrant for my arrest may be issued and new charges may be filed against me.**

**Option 3: Attend a defensive driving class.**

One moving violation may be dismissed. **If you have a commercial driver license, you are not eligible for defensive driving class regardless of the vehicle you were driving.** You can attend this class once every twelve (12) months for any eligible violations listed in the **Fine/Sanction Schedule**. You may attend class for only ONE violation even if there are multiple eligible violations listed on the traffic citation. You must pay a fine, appear in court, or request a hearing for any additional violations. For information on schools, call 1-888-334-5565 or visit [www.azdrive.com](http://www.azdrive.com).

- You may be eligible to attend defensive driving class if:**
- You have not previously attended a defensive driving class for a citation issued within the last 12 months.
  - You have a valid driver license.
  - The violation did not involve an accident with serious injury or death.
  - You are not requesting a hearing.

**YOU MUST COMPLETE DEFENSIVE DRIVING CLASS AT LEAST SEVEN (7) DAYS PRIOR TO YOUR APPEARANCE DATE SHOWN ON THE CITATION.**

- Advantages of attending class for the violation:
- There is no fine or conviction (you pay only the school diversion fee).
  - You do not appear in court for that violation.
  - No points are placed on your driving record for that violation.
  - Persons with a graduated license will not have to attend mandatory Traffic Survival School through MVD.
  - Persons with a red light violation of any kind will not have to attend mandatory Traffic Survival School through MVD.

Registration Instructions:  
Contact an accredited school within five days of receiving your citation. The school will notify you within two business days if you are not eligible. You must complete the class at least seven days before the court appearance date written on the citation. The school will give you the cost of their course. If you register for class online, you must be sure to click on Arizona (not your home state).

On the day of class, bring your driver license, citation and money order. The school does not accept cash or personal checks. To replace a copy of a lost citation, call the appropriate court above.

**Option 4: Appear in court.**

The courts listed above are open from 8:00 a.m. to 5:00 p.m., Monday through Friday, except holidays. During these hours, you may pay the fine(s), show proof of compliance, and/or request a hearing/trial. If your appearance date falls on a holiday or weekend you should appear the following normal business day.

If your charges are criminal, you must appear in court at 8:30 a.m. You may be required to see a judge, but you will not have a courtroom hearing with witnesses that day. **If you appear late, you may be required to return another day.**

**MISCELLANEOUS:**  
No court date extensions will be granted by phone. Requests for extensions must be made in person or in writing and must be faxed, mailed or delivered at least 10 (ten) days prior to your court date.  
**IF YOUR APPEARANCE DATE HAS PASSED,** call the court immediately as a warrant for your arrest may have been issued and/or your case sent to collections, default judgment entered, and/or your driving privileges suspended.  
**NOTICE TO OUT-OF-STATE RESIDENTS:** Pursuant to the Non-Resident Violator Compact, failure to comply with a traffic citation may result in a suspension of your driver license in your home state, and additional fees or penalties may be assessed.

**FINE/SANCTION SCHEDULE (Effective September 6, 2017)**

**You must appear in court on or before the appearance date on your traffic citation if your violation is not listed below or if your violation is for an accident resulting in serious injury or death (see Option 4: Appear in court).**

**For all speeding violations other than a violation marked as an accident:** To determine the fine amount for these violations, refer to the Speed section on the citation. Subtract the number written in the Posted box from the number written in the Approx box. The resulting number is the mph over the speed limit. To the right of each mph over the speed limit category below is the correct fine amount to be paid. See the appropriate Violation Code below. Look at both columns.

**Violations Eligible for Defensive Driving Class**

(These violations carry points in Arizona. Completing Defensive Driving Class on time will keep the points off your record for one violation.)

Find the violation code written in the Section box on the citation and match it to a violation code listed below under the Violation Code heading. The correct fine amount for that violation is listed in the Amount column to the right. Use the Default Amount if you are paying after the appearance date written on the citation. **YOU MUST BE SURE TO SIGN OPTION 1 or 2 and mail it with your payment.**
